(Grade 11), Project "Development of Natural Adhesives from Native Hawaiian Plants to Reduce Skin Irritation from Common Adhesive Bandages", U.S. Metric Association Award and Best in Category- Plant Sciences Award; and Kian S (Grade 11), Project "Sponge Studies: Assessing the Effects of the Ecological Impacts on Mycale grandis Detritus Production, and Use as a Natural Deep Sea eDNA Sampler", NOAA award, Yale Science & Engineering award, Society for in Vitro Biology award, Best in Category- Environmental Engineering, First Place at HonSEF.
